

# RLS Hot Lunch Program

Thank you for participating in our school Hot Lunch Program. Our goal is to make meals kid-friendly and healthy. Our cooks are trained certified food managers. We are licensed and monitored by the state of Minnesota. This means that we have nutritional and cooking guidelines that we need to follow to ensure your child's health and safety.

**Lunch prices.** PreK through 4<sup>th</sup> grade is \$2.50/meal, 5<sup>th</sup>-8<sup>th</sup> grade is \$2.70/meal. Milk is included with the meal. Students with sack lunch can purchase milk for \$0.40. Eligible students may get school lunch free or at a reduced price of \$0.40/lunch.

**Hot Lunch billing will be done through TADS.** An email was sent by our Financial Administrator Monday 8/20/2018 asking for your verification that your children will participate in Hot Lunch. Students participating in hot lunch will see a \$25 charge per student in September to cover the first week's meals. There will be an option starting in September to use TADS to pre-pay your hot lunch account. (More information coming soon after school starts.) If your student only plans to purchase milks or less than 4 meals per month, you will have the option to select \$10 for the initial week's milks.

TADS will be updated each month shortly after the start of the month with new charges from the previous month, and will also show your current balance in your Hot Lunch Account.

**Allergies & meal modifications.** All meals served must meet standards established by the U.S. Department of Agriculture. If a student has a food allergy, we need a parent/guardian to fill out our allergy information form. This form will be available at registration or the school office. If a student has been determined by a physician to have a disability and the disability prevents the student from eating the regular meal, the school will make reasonable modifications or substitutions prescribed in writing by the physician at no additional charge. Lactose-intolerant students need a written request from the parent/guardian to have the school provide lactose-reduced milk. **This request must be made in writing to Marla Brandmeyer, Hot Lunch Manager, Resurrection Lutheran School, 4520 19<sup>th</sup> Avenue NW, Rochester, MN 55901, or sent via email to: hotlunch@resurrection-wels.org.**

**Application for educational benefits.** Parents/guardians who wish to apply for free or reduced lunch benefits need to complete an application. Applications are available at registration or can be picked up anytime in the school office. If you received free or reduced meals last year you must reapply this year. Meal benefits begin when application is approved.
